# Updates to Reimbursement Process for Developmental Evaluation Center (DEC) Services and Managed Care Organizations (MCŎs)

Services performed through DECs on or after Feb. 1, 2024, are encountering reimbursement changes. The reimbursement for these services is now the responsibility of the MCOs for Medicaid members enrolled in an MCO.

There are currently three DECs in South Carolina. You will find the DEC services outlined in the South Carolina Department of Health and Human Services (SCDHHS) Autism Spectrum Disorder\* and Clinic Services\* provider manual.

### Obstructive Sleep Apnea (OSA) Treatment

As of April 1, 2024, SCDHHS has expanded coverage to include treatment for mild OSA with a Food and Drug Administration (FDA)approved prescription device named eXciteOSA. Treatment will be covered under the DME benefit.

### Extensions of **Telehealth Services**

SCDHHS has announced an additional extension of telehealth flexibilities issued during the federal public health emergency (PHE) for COVID-19. The PHE expired on May 11, 2023. Flexibilities were allowed for one year after the date of the PHE expiration.

SCDHHS has now extended the flexibilities through Dec. 31, 2024. The flexibilities including telehealth flexibilities are included in the provider manual found on the SCDHHS website.

## Prior Authorization Updates for Medications Billed Under the Medical Benefit
